

Terms of use

These are the Terms and Conditions on which Looking for an Eventure PTY Ltd (**Looking for an Eventure**) permits users to access and use the website located at www.lookingforaneventure.com. There are links within the Looking for an Eventure PTY Ltd website that link to other external websites that we have no direct connection to. Therefore it is the users responsibility to check the site is the site they want to be on, responsibility lies solely with the user. Accessing the Looking for an Eventure PTY Ltd website the user is agreeing to the terms and conditions and privacy policy of the website, if users do not agree with any of these conditions they must leave the website immediately.

These terms and conditions relate to all users of the website www.lookingforaneventure.com. It is important that these are adhered to. If you cannot comply you should leave the website immediately.

Your subscription is based on a monthly payment of \$10, it is the users responsibility to cancel their recurring payment by clicking on the 'cancel subscription' button at www.lookingforaneventure.com. You can cancel your payment at any time allowing at least 2 days for response for Looking for an Eventure PTY Ltd to enable this in the backend.

16. Looking for an Eventure PTY Ltd uses the Powr job board app for its 'opportunity search' which comply's with their own terms and conditions

17. In relation to the payment method it is the users responsibility to cancel the payment as it will automatically be renewed. This can be done under the 'cancel subscription' button, where this doesn't function, it is the users responsibility to go to the contact us page and send a message advising this.

18. No refunds are made under accidental purchase, it is the users responsibility to check all conditions before purchasing.

19. By using Looking for an Eventure and its use of posting jobs, you permit that you have read and are not in breach of rights for all User Content that you post, you are solely responsible for the User Content that you post, that the User Content is not in breach of the original sources terms and conditions and that you are not in violation of any applicable laws and that the User Content will not cause injury or loss to any person.
